The Government of Mozambique has received funding from the International Fund for Agricultural Development (IFAD), in the form of loans and grants to finance the implementation of the Pro-poor Value Chain Development Project in the Maputo and Limpopo Corridors (PROSUL) aiming at supporting three value chains, namely: Horticulture, Cassava and Red Meat. The Agricultural Development Fund (FDA) is responsible for the Project coordination, through a Project Management Team Based in Xai-Xai, Gaza province.
2. The Gapi - SI / Novedades Agricolas Consortium, contracted by the FDA to lead the implementation of the Horticulture Value Chain Development Component intends to apply part of the available funding for the acquisition of Agricultural Inputs, namely: seeds, fertilizers and pesticides, grouped in seven (07) lots, as per the table below. As such, interested and qualified bidders are invited to submit their proposals in sealed envelopes in Meticaís (MZN), for the provision of the goods mentioned below and as per the bidding documents.
